SPRING APPLICATION PERIOD & DEADLINES

- Use this form to apply for one author visit taking place between **April 1, 2019** and **August 31, 2019**.
- Applications are accepted between **November 26, 2018** and **January 28, 2019**.

EQUITY INITIATIVE FUNDING

- If demand for this program exceeds funding, applications from schools serving vulnerable populations* will be prioritized, as will applications from schools who wish to host an author who is Black, Indigenous, racialized, LGBTQI2S, or living with a disability. For schools serving vulnerable populations, the Union will pay the full amount of the base reading rate. Schools remain responsible for paying any difference between an author's full fee and the subsidy covered by the Union.
- Applications that do not qualify for Equity Initiative Funding are welcome and will receive funding on a first come, first served basis after Equity Initiative Funding has been allocated.

READING FEES

- The base reading rate is \$400 per full-day visit (3 or 4 sessions) and \$300 per half-day visit (1 or 2 sessions).
- The Union subsidizes half of this base fee (paid directly to the author) and the school pays the remaining amount to the author. For schools serving vulnerable populations, the Union will pay the full amount of the base reading fee.
- Schools are responsible for paying the difference between an author's full fee and the subsidy covered by the Union.

OTHER DETAILS

- Each school is eligible for one subsidy per funding period (April 1 – March 31).
- Requests will automatically be placed under an alternate choice if you request an unavailable author. If you do not list alternates and you request an unavailable author, your application will not be considered for funding.
- All schools must apply separately; two schools cannot split one full-day visit.
- Any form of recording, taping, or broadcasting of a visit without prior written approval from the author is strictly prohibited.
